### 2018 OFFICIAL RULES

#### **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The AMC "Guest Satisfaction Survey Giveaway" promotion ("Promotion") is a monthly giveaway commencing at 12:01 am (CST) on January 1, 2018 and continuing on a monthly basis until December 31, 2018. The sponsor of this Promotion is American Multi-Cinema, Inc. 11500 Ash Street, Leawood, KS 66211 ("Sponsor"). The Promotion is subject to these Official Rules, and all participants (or their parents/legal guardians if they are residents of jurisdictions that deem them to be minors) agree to be bound by the terms and conditions herein.
